CDI programs are the single strongest tool in a health system's toolkit against the onslaught of reimbursement regulations and third party payor policies. Its successful implementation has wide reaching benefits including increased institutional standing with peers, higher/quicker reimbursement, decreased denials, higher win rates on appeals and better quality metrics.

- **CDIS Education** This clinically focused education forms the foundation of the CDI toolkit and helps to turn clinical professionals into CDI specialists.
- **CDI Operational and Reconciliation Processes** We outline formal reconciliation, assignment, query/clarification, response and compliance procedures establishing the new department with a workflow and metrics.
- Coder Education and Feedback Loops Coders are given a primer on the pathophysiology concepts and terminology they see frequently documented giving them the ability to translate this lexicon into coding. This also helps them formulate queries that are more readily understood by clinicians.
- Physician Advisor Guidance Learn how to use effective techniques for physician engagement and build efficient query/clarification response mechanisms.
- Specialty Specific Provider Education Each specialty receives tailored content for the diagnoses and procedures that represent their practice. Your providers will understand *why* they should care about their accuracy and specificity, *what* difference it makes, and *how* they can accomplish this goal.

OUR PHILOSOPHY

The acronym S.M.R.T. stands for *Saying Medically Relevant Things*. It is our contention that a large communication gap exists between the originators of most clinical documentation (providers) and those applying codes and combating reimbursement issues.
